The Geneva Prize for Human Rights in Psychiatry - Invitation to submit candidatures

The Geneva Prize for Human Rights in Psychiatry is intended to acknowledge an individual (with no restriction as to gender, age or nationality), or an institution or association (with governmental or non-governmental status) for exceptional achievement at regional, national or international level in promoting equity and humane qualities of care for people with mental

illness, reducing negative discrimination of the mentally ill or defending the rights of people with mental illness, and supporting the application of ethical principles in psychiatric services. The Prize, consisting of a diploma, a medal and a monetary award of 20,000 Swiss Francs, is awarded once every three years, usually during the World Congress of Psychiatry. Deadline for nominations for the 2014 Prize is the 31st March 2014. For further detail, see www.geneva-prize.ch.

EUFAMI featured on the family caregivers unite! Radio show

The Family Caregivers Unite! talk show is for family caregivers featuring Family caregivers talking together, Family caregivers talking with experts, Family caregivers sharing experiences, Family caregivers

saying what makes the sun shine for them and Family caregivers calling for change. The show is hosted by Dr Gordon Atherley and broadcast by VoiceAmerica Internet Talk Radio, the world leader in Internet Talk Radio. VoiceAmerica reports that, as of October 28, 2013, Family Caregivers Unite! reaches over 520,000 listeners in 22 different countries, with over 230 episodes accessed in the on-demand library, and is growing.

Health inequalities in the EU

Recently the EU-funded report "Health Inequalities in the EU", produced by a consortium led by Sir Michael Marmot (University College, London) was published. The main findings have been included in the Commission's progress report on the implementation of the 2009 Communication, 'Solidarity in Health: Reducing Health Inequalities in the EU' published on 9th September 2013. Findings include (a) Inequalities in life expectancy - no evidence of an overall decline between EU regions and (b) Inequalities in infant mortality - the gap between Member States narrowed by 12% between the period 2002-04 and 2007-09. The report warns that the current financial, economic and social crisis is threatening to undermine existing policies, and may negatively affect health inequalities. It urges that tackling health inequalities remain a priority and be mainstreamed into the health sector's core policies, and addressed also by other sectors.
