Despite the progress, still much to be done for mental health, says Julia Ward MEP

Julia Ward, MEP wrote an opinion piece in the 'Parliament Magazine' emphasizing the affects our socio-economic environment has on our mental well-being. She argues for an 'all of society' approach which would allow us to tackle negative impact gender inequalities have on mental wellbeing for women. She further notes that the there is a need take a lifespan approach, promote education at all levels and address the impact of emerging technologies and the internet has on mental health. EUFAMI welcomes and considers these potential initiatives to be the first steps to challenge stereotypes around mental health and wellbeing.

Next of kin's experiences of involvement during involuntary hospitalisation and coercion in Norway – research article

The 'Next of kin's experiences of involvement during involuntary hospitalisation and coercion' study conducted in Norway showed that the involvement of family members of persons with severe mental illness is still far from satisfactory. Just as our C4C survey has shown the next of kin in the study felt neglected, unappreciated and dismissed. The paper discusses possible reasons for the gap between public policies and practice which deserve more attention
